### **Information & Regulations**

#### CONDITION OF ENTRY

It is a condition of entry that all exhibitors undertake to abide by the rules and regulations of the Association. All exhibitors, their contractors and employees whilst on the Showground shall take directions as required from the stewards and officials of the Show.

#### **COVID 19 REGULATIONS**

All exhibitors will be required to adhere to all current, Government legislation & issued Covid-19 quidelines as at the date of show in addition to requirements by the H&DAA.

#### LIABILITY

The Association will only be responsible for death, injury, damage or loss caused to an exhibitor or to his/her servants, agents or to any exhibit or machinery where negligence is proven. The exhibitor shall indemnify the Association against all claims, losses, damage and expenses arising from his/her participation in the Show.

The Association will in no case accept liability for any loss or damage where direct or indirect arising from or caused by the abandonment or cancellation of the Show.

EXHIBITORS ARE REQUIRED TO HAVE THEIR OWN APPROPRIATE INSURANCE. ALL EXHIBITS TO BE INSURED.

#### **ACCESS AND MOVEMENT**

Exhibitors will enter and exit the Showground where directed. Tractors and machinery may be sited on the Showground at the owner's risk. Before 8.30pm on the night before Show or before 8.30am on the day of show – Thursday 1st August.

On entering the Showground the appointed stewards will direct exhibitors to their show area. THERE WILL BE NO MOVEMENT OF VEHICLES ON THE SHOWGROUND AFTER 10.00AM ON SHOWDAYS EXCEPT WHERE DIRECTED FOR PARADES. ALL VEHICLES ARE TO GIVE WAY TO PEDESTRIANS WHEN ON THE MOVE. TRACTORS WILL NOT BE PERMITTED TO LEAVE THE SHOW BEFORE 6.00PM ON THURSDAY 1st AUGUST.

#### AGE OF TRACTOR DRIVERS

There will be a minimum age of 13 years for tractor drivers.

#### TRACKED VEHICLES

Vehicles on tracks or with spud wheels will not be allowed to move about the Showground and must be brought in on trailers.

#### **OPERATION OF MACHINERY**

Exhibitors must comply with all the necessary safety regulations concerning the operation of engines and machinery. Exhibitors are responsible for the safe running of the equipment and must ensure that working machinery is cordoned off from the public.

#### **ANIMAL HEALTH PRECAUTIONS**

All vehicles and exhibits entering the Showground must be clean. The Association reserves the right to refuse entry to vehicles which in their opinion, are not in a clean condition.
